## **Global Shipping Instructions and Helpful Hints**

Freeman Exhibit Transportation, (FET), provides a Door to Door transportation solution that includes custom clearance in most all countries. We will pick up your exhibit materials from your designated door and deliver to your stand/booth or to the venue dock holding your show. We will assist you to prepare your shipping documents to streamline the transportation and customs process.

Packing of exhibit materials:

You should pack your exhibit materials in a manner to withstand handling at many different locations along the way to your show. Make sure the contents are not too heavy for the packaging and are properly secured inside the container.

All solid wood packaging containers shipping into the USA must comply with the U.S. Department of Agriculture standards. The Final Rule concerning the importation of wood packaging material (WPM) can be found at:

http://www.aphis.usda.gov/import\_export/plants/plant\_imports/downloads/w pm\_docket02-032-3.pdf. Types of wood that are exempt are manufactured wood such as plywood, veneer, and fiberboard/OSB. If your shipping containers do not comply, they will be returned to the origin country and fines could be assessed. All charges; penalties, storage fees, processing fees, and fines will be at the expense of the shipper/exhibitor.

## Labeling of Shipping Containers:

Ensure your container is labeled with an indelible ink. Some self-adhesive labels can come loose in transit, so make sure you pick the proper labeling for your containers.

## <u>ISF - 10 + 2:</u>

## (For ocean shipments only into the U.S.)

United States Customs and Border Protection (CBP) has announced a new rule, known as the **Importer Security Filing** (ISF) or more commonly called **10+2**; which requires cargo information, for security purposes, to be transmitted to the agency at least 24 hours before goods are loaded onto an ocean vessel for shipment into the U.S. 10+2 is pursuant to section 203 of the SAFE Port Act, and requires importers to provide 10 data elements to CBP, as well as 2 more data elements from the carrier. Freeman will **not** be held liable for any non-compliance for not filing the ISF for any exhibitor and or client.

## **Restricted Articles:**

All countries have different requirements on restricted articles being imported into their country. Be sure to check with each country if you should have any questions prior to shipping to your show or event. Some items require that other government agencies must inspect prior to customs release. To follow you will find a list of items that should cause you to ask questions.

This list is by no means a complete list of restricted articles and should not be viewed as such.

- 1.) Medical devices
- 2.) Drugs of any kind
- 3.) Firearms and ammunition
- 4.) Alcoholic beverages
- 5.) Textiles
- 6.) Wearing apparel
- 7.) Computers
- 8.) Lithium Batteries (laptop batteries)
- 9.) Televisions
- 10.) Any Food stuffs for human consumption; i.e.: candy, spices, coffee, fresh or frozen vegetables or fruit etc.

## **ATA CARNETS:**

A Carnet or ATA Carnet is an international customs document issued by 87 countries and territories. It is presented when entering a Carnet country with merchandise or equipment that will be re-exported within 12 months. It is sometimes called The Merchandise Passport for boomerang freight. Exhibitors must apply for the ATA Carnet in the origin country of your shipments with the agency governing ATA Carnets.

Upon presentation, the Carnet permits the equipment or merchandise to clear customs without the payment of import duties and import taxes\* such as VAT or GST. Payment is not necessary because the Carnet guarantees that the merchandise or equipment will be re-exported within a year. Thus,

the use of a Carnet is a way of temporarily importing into foreign countries without payment of import duties and taxes. Carnets also serve as the U.S. registration of goods so that the goods can re-enter the U.S. without payment of duties and taxes.

When using a Carnet be sure to check and see if the country you are going is a participating country.

When using a Carnet, do not pack additional items not covered by the Carnet in the same shipping container. It is best to make two (2) shipments if shipping additional items. The customs clearance process is different between items for a regular import, sometimes called a definitive entry or regular consumption entry and the clearance of a Carnet shipment.

An ATA Carnet may be used as a **Certificate of Registration** (<u>CBP</u> <u>CF4455</u>) departing and returning to the U.S. regardless of whether the carnet will be used in a carnet or non-carnet country.

Freeman will assist with clearing of Carnet shipments.

## Temporary Import Bond/TIB:

Freeman can assist with TIB entries. When a shipment has been entered as a Temporary Import it is required that the exhibitor use Freeman Exhibit Transportation, FET, for both import and export. The export document descriptions must match identically to the documents used for import. When shipping on a TIB you should not include any items that will not be returned. i.e.; handouts, giveaway pens, promotional items that will stay in the country of import or items the exhibitor intends selling at the close of the show or event. These items should be moved in a separate shipment. The Temporary Import Bond must be canceled at the time of export. If this is not done the applicable duty, taxes, and any penalties will be due the exhibitor. In most cases it is cheaper and easier to not use a TIB and enter as a regular consumption/definitive entry as most exhibition shipments are duty free.

## Valuation:

FET can assist you with additional insurance for your shipment. If additional insurance is required, make sure it is broken out on your transportation quote and also that it is shown on the bill of lading.

## **Method of Payment:**

Method of Payment must be on file with Freeman prior to FET and its global partners picking up your shipment to move to your show or event. FET prefers credit card be on file over other methods because airlines reweigh and check the dimensions of your shipment and could cause your shipping charges to increase or decrease because of the variance.

## Lead Time:

On global shipments it is important to allow enough time for the customs broker in the country you are traveling to make the customs clearance. It is to allocate time for adverse weather conditions, holidays, and in some countries customs can strike. We like to see your shipment in the country your show or event is in, 14 days prior to your move-in date. This should give your chosen customs broker sufficient time to clear and have delivered your shipment to your show or event.

The outside of your wood packing must be stamped with the mark issued by accredited inspection agencies. Packing materials made from plywood or plastic are exempt from the above regulations.
